Chair's Message

Welcome to the first eBulletin of 2015. At the most recent Board meeting we reflected on the progress made by the organisation during 2014 and discussed the programme of work for the year ahead.

2014 was a busy year for the organisation with nearly 2000 new admissions to the Register and an increase in demand for our services. Searches of the Register averaged almost 1000 a day and visitors to the separate ARB website domain reached a quarter of a million for the first time. We also discussed the [Annual Report from the Remuneration Committee](#) and the [Annual Report on Third Party Review](#), both of which evaluated progress during last year and noted

solid organisational performance. 2014 also saw the commencement of the periodic review, conducted by the Department for Communities and Local Government (DCLG), this is an independent review into the regulation of the profession. We have a section on our website where we post [updates relating to the periodic review](#).

As a Board Team, and as part of our commitment to good governance principles, for the third year running we conducted a self-evaluation exercise. We collected together views on how we have delivered on our regulatory remit. We reflected on the contributions made and set a list of actions to further strengthen our ability to operate in line with the five principles of regulatory best practice – proportionality, accountability, consistency, transparency and targeting. Prescribed Exam – Extension of Transitional Arrangements

The Board agreed at its meeting of 11 February 2015 to extend transitional arrangements for Prescribed Examination candidates who commenced a course of study before October 2013, and where graduates from the same cohort (or earlier cohorts from the same programme) had made an application for Prescribed Examination which was accepted by the Board. Strengthening regulation

In line with our commitment to best practice in Board governance, the Board discussed the findings of the 2014 Board self-evaluation exercise at its most recent meeting. This review incorporated the Board's perspectives on the role of the Board; the Board's ethos and approach; risk management; performance

management; Board effectiveness; relationships with stakeholders; Board composition and corporate reporting. The following [paper](#) sets out the context for this exercise. Prescription of Qualifications

At the last Board meeting on 11 February 2015, the Board considered an application from a Higher Education institution seeking to renew prescription of its qualifications under the Architects Act 1997.

The Board decided that prescription of the following qualifications should continue until September 2020:

- University of Bath
- BSc (Hons) Architecture – Part 1
- Master of Architecture – Part 2
- Postgraduate Certificate in Professional Practice – Part 3

In January, a company called The Market Design & Build Ltd, based in Middlesex, was ordered to pay a record £10,000 in fines and costs for misusing the title architect. The business did not employ an architect but, despite numerous warnings, it continued to refer to itself as ‘Architects’ and use the ARB logo on its correspondence, website and advertising – including signage on company vehicles. Periodic review

In November 2014, the Department for Communities and Local Government (DCLG) reported on the outcome of phase one of the periodic review, concluding that there remains a need for continued statutory regulation. Phase two of the review is underway with a detailed focus on two key regulatory functions. These are setting the standards of entry to the profession (what is often referred to as the prescription process) and the remit of the professional standards function (which deals with setting the Code of Conduct and the complaints process). Dear Architect – a new information column from the Professional Standards Team

In this eBulletin we want to draw your attention to two new pieces of guidance produced by the Professional Standards Team.

ARB has recently issued guidance on the new [Construction \(Design and Management\) Regulations](#) which will come into force on the 6 April 2015. One of the main changes which will be brought in under the Regulations is for “Principal Designers” to replace the role currently undertaken by CDM co-ordinators. The ARB guidance note summarises the areas for which architects will be responsible, if they are acting as Principal Designer.

Additionally, ARB’s guidance on professional indemnity insurance has been re-issued. All architects should be aware of the importance of holding adequate and appropriate insurance and this useful document covers areas such as the minimum levels of insurance, run-off cover and notification of any potential claims.
